1. CALL TO ORDER

The Park Board of the City of Gun Barrel City, Texas met in a Regular Meeting in City Hall, Council Chambers, located at 1716 West Main Street, Gun Barrel City, Texas, on Monday, March 10, 2025 at 4:00pm

2. ROLL CALL & QUORUM

Chairperson, Monica Damiano called the meeting to order at 4:00 p.m. Roll was called and a quorum established. Members in attendance included Monica Damiano, Foster Brady, Renetta Burson, Annette Everett and Gilbert Shelby. Elga Desautel was absent.

3. NEW BUSINESS

3.A Consider and take action to approve the February 10, 2025, meeting minutes. (Desautel)

Elga Desautel not in attendance. No discussion. Renetta Burson makes a motion to approve the minutes from February 10. Foster Brady – 2nd. All in favor. Motion passes.

3.B Discussion regarding Chapter 40 of the Code of Ordinances for feedback to be given to the Ordinance Review Committee. (City Manager)

City Council reviews all ordinances, including park board ordinances. Angie made some changes copying Chapter 34 into Chapter 40. Advertising section was added – no advertising to be done without permission. Angie also added a section about no pets in playground area or an event with mass gatherings. Any gatherings of 100 or more people need to fill out a form. Several ordinances were written as far back as 2005. A lot of verbiage has been updated. A final draft will be given to the park board to review at a later date. The reason for the detailed ordinances is to give the city police department the ability to enforce the rules.

3.C Consider and take action on improvements to the Gun Barrel City Park website link. (Burson)

Parks and Recs have their own page with a link to the city park. Brooke is working on keeping News Flash items up to date. Suggestion made to include park board accomplishments pertaining to park Improvements, example, new disc golf signs, and activities that take place in the park (calendar of events). It's difficult to update everything that takes place at the park except for city sponsored events. There's also a Friends of the Park Facebook page.

3.D Update on the Library box. (Burson)

The free library boxes have not yet been ordered by the sponsor. The sponsor thought if the park board had a 501C3 status, the board could order the boxes and they would reimburse. We do not have that status. Renetta will follow up.

3.E Update on grants. (Brady)

Texas Parks and Wildlife have several grants. Grant application needs to be in by February 2026. We would split 80/20. Pricing needs to be included in the application. Beginning price for asphalt for the trail is approx. \$45,000 for a portion of the half mile trail.

3.F Consider and take action on Walkathon in September. (Desautel/Damiano)

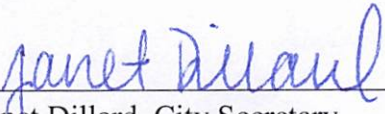

ADJOURNMENT

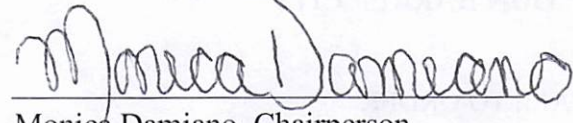
Renetta Burson makes a motion to adjourn. Foster Brady – 2nd. All in favor. Motion passes.
